



## Usage Regulations for "Salzachöfen"

### 1. General

The municipality of Golling provides the natural monument "Salzachöfen" to the public for viewing for a fee. There is no entitlement to access the gorge.

### 2. Opening Hours

The Salzachöfen are open daily from May to October from 07:30 to 20:00. Short-term closures may occur for safety reasons. Opening hours may be subject to change at short notice due to special events, government regulations, etc.

### 3. Passage and Usage Regulations

When walking through the Salzachöfen and using the surrounding hiking trails, all visitors must behave in a manner that does not endanger, harm, or unreasonably obstruct or disturb others. Sturdy footwear with appropriate tread is required. Hiking in alpine terrain is inherently dangerous and requires a high level of caution and personal responsibility. Entering and staying in the Salzachöfen is at your own risk. Parents are responsible for their children.

Please be aware of uneven terrain (such as rocks on the path), rocky overhangs, steep slopes, varying step levels, and low clearances. **Children up to the age of 8 years and those under a height of 1.25 meters must be accompanied and held by the hand at all times while in the Salzachöfen. This also applies to individuals with special needs.**

Due to the alpine nature of the terrain and narrow passageways, access through the Salzachöfen is unfortunately **not suitable for wheelchair users or persons using mobility aids** (e.g., walkers).

In particular, the following are prohibited:

- Disposing of waste or littering the area.
- Throwing objects from the bridge.
- Bringing canoes, bicycles, strollers, wheelchairs, and similar bulky items through the gorge or on the immediate access paths. This also applies to foldable models. When using child carriers, attention must be paid to height.
- Leaving the designated paths.
- Entering the Salzachöfen under the influence of alcohol or other intoxicating substances.

- Climbing on the safety barriers.

#### 4. Right of Admission

The municipality of Golling exercises the right of admission on the premises of the Salzachöfen. Orders from the ticket personnel or other employees of the municipality of Golling must be followed immediately. In case of serious or repeated violations, a ban from the Salzachöfen may be issued (ban from premises). Additionally, the municipality of Golling reserves the right to file a report with the police if necessary.

#### 5. Liability


Despite all safety measures, certain dangers such as rockfall, ice, slippery surfaces, falls, etc., and associated increased risks of accidents and injuries with potential risks to life and limb cannot be completely prevented due to natural conditions. All visitors must be aware of these dangers and risks and pass through the Salzachöfen at their own risk.

The municipality of Golling is liable for property damage only to the extent that it is based on a breach of a material contractual obligation or on intentional or grossly negligent behavior by the municipality, one of its legal representatives, or vicarious agents. If a material contractual obligation is negligently breached, the liability of the municipality of Golling is limited to the foreseeable, typical damage. A material contractual obligation exists if its fulfillment makes the proper execution of the contract possible or if the contractual partner relies on compliance with it and may rely on it.

#### 6. Effective Date

These usage regulations come into effect on May 1, 2025.
